(1) CALL TO ORDER

A regular meeting of the Citrus County Hospital Board of Trustees was held Monday, **March 24th, 2025,** in the Conference Room at 123 N. Apopka Avenue, Inverness, Florida 34450. Chairman Dr. Mark Fallows called the meeting to order at 6:00 P.M.

(6) LEGAL

Attorney Cliff Shepard, via Zoom, provided the latest update on the AHCA case. The case has now been narrowed down to a single issue: the realignment of cost centers. Both experts remain in disagreement on this matter. AHCA's final proposal requires CCHB to pay an additional \$1.3 million.

MOTION by Dr. Wallis to offer an additional recoupment of 650K plus AHCA would keep the 1.75 million previously paid in recoupment. The CCHB further authorizes Chairman Dr. Fallows to execute any and all documents needed to effectuate complete resolution with AHCA. If the offer is rejected by AHCA then

CCHB will continue to trial on the single realignment cost issue, second by Mr. Bartell. No further discussion, the Motion passed unanimously, 3 -0.

MOTION by Dr. Wallis to accept the Minutes, second by Mr. Bartell. No further discussion, the Motion passed unanimously, 3-0.

(8) FINANCE COMMITTEE REPORT
